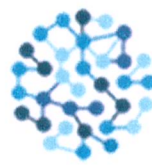
Commitment to achieving Net Zero

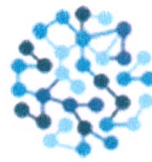

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2021 baseline. The carbon emission reduction achieved by these schemes equate to 4 tCO₂e, a 100 %ge reduction against the 2022 baseline and the measures will be in effect when performing the contract

The Blue Globe Consultants Ltd has purchased carbon credits equal or above 15 tCO₂e through the Forest Carbon Club and will do so each year. Additionally, we are committed to reducing any flights or long-distance travel unless business critical.
